SE-4094 Reporting - Review & Audit

- The State School Aid Act, MCL 388.1618 (7), reads in part
- "By not later than 1 week after the last business day in September of each year, each district and intermediate district shall file with the center the <u>audited</u> <u>transportation expenditure report</u>, known as "SE-4094", on a form and in the manner prescribed by the center. <u>An intermediate district shall certify the audit of a district's report</u>."

 - FTE Conversion Table Interactive
 - FTE Conversion Table
