American Rescue Plan (ARP) Funding



ARP ESSER III Formula

- Formula Grant
- Set-Aside (20%) for Learning Loss
- LEA Plan for Use of Funds & Return to In-Person Instruction and Continuity of Services Plan

ARP Section 11t Equalization

- Designated Grant
- Set-Aside (51.4%) for Learning Loss; (10.3%) for Summer Programming; (10.3%) for Before/After School Programming
- LEA Plan for Use of Funds & Return to In-Person Instruction and Continuity of Services Plan

ARP Section 11bb – GEER II

- Designated Grant
- Same as GEER I (50% minimum Economically Disadvantaged)
- No set-aside or Plan requirements
- Recaptured ARP EANS II funds















ARP Grant Timelines




ARP Grant Obligation Period Concludes	Monday, September 30, 2024	All ARP funds must be obligated by Monday, September 30, 2024 , with no exceptions. This means that: <ul style="list-style-type: none">All equipment, supplies, services, and assistance under the ARP program must be provided (services), or ordered/requested from the vendor by Monday, September 30, 2024, and approved by MDE in the application/budget.
ARP Grant Performance Period Concludes	Friday, November 29, 2024	The ARP Program Period of Performance concludes on Friday, November 29, 2024 . This means that: <ul style="list-style-type: none">ARP recipients must be in receipt of all equipment and supplies of validly obligated (MDE approved) purchases that will be submitted for possible payment by Friday, November 29, 2024.Final Expenditure Report (FER) is due by November 29, 2024.Note that services are obligated on the day they are performance, which means that all services provided must end by Monday, September 30, 2024.
ARP Grant Liquidation Period Concludes	Monday, December 30, 2024	All requests for payment must be submitted on or before Monday, December 30, 2024 , to be considered for payment using ARP funding.
ARP Grant Close Out	Wednesday, January 29, 2025	MDE, as the SEA, must fully liquidate and close out ARP funding.

Late Liquidation Extension Details:

- USED has authority to approve liquidation extension requests based upon the specific facts and circumstances of a given obligation and upon written request of a MDE on behalf of itself or its subrecipient
- MDE **MUST** submit complete request = Reflects a forecast of funds to be liquidated during the extension period. USED recommends submissions by December 31, 2024.
- Subrecipient **MUST** complete authorized template, by individual expenditure, signed by authorized official.
- Subrecipient **MUST** provide a cover letter that explains how the ARP liquidation extension request contributes to the acceleration of academic success for students

Late Liquidation Extension Resources:

As a reminder, any grantee that intends to submit an ARP Act liquidation extension request for itself or its subrecipients must complete a request template detailing the grantee and subrecipient funds included in the request and provide a signed attestation from an authorizing official. Additionally, the grantee must provide a cover letter that explains how the ARP ESSER or ARP EANS liquidation extension request contributes to the acceleration of academic success for students.

- 20% Set-Aside for Learning Loss – Application
- LEA Plan for Use of Funds – LEA Local Responsibility (Survey)
- Return to In-Person Instruction & Continuity of Services Plan – LEA Local Responsibility (Survey)

State Grants Q & A

- **37 total new grants (36 in state aid and 1 important one in supplemental)**
 - **29 (78%) are designated grants (assigned to a specific district or vendor)**
 - **5 new grants are competitive and 3 are formula-based grants**
- **Sec. 11bb: Re-Allocated ARP EANS II funds (obligation by Sept. 30, 2024) - Designated**
- **Sec. 12c: School Consolidation and Infrastructure - Competitive**
- **Sec. 25l: Early Warning – Competitive, must be ISD**
- **Sec. 27k: Federal Student Loan Repayment - Competitive**
- **Sec. 35n: READ Innovation Competition - Competitive**
- **Sec. 99(17): MI Student Voice Perception - Competitive**
