- 5. School Finance Research Foundation (SFRF) Statewide Infrastructure Study Kristin Mixon, Plante Moran REIA and Paul Wills, Plante Moran CRESA
  - School Finance Research Foundation
    - Diverse group of business leaders and education experts across the state of Michigan.
    - Composed of 12 ISD leaders and 10 MAISA regions.
    - The School Finance Research Collaborative's (SFRC) school adequacy study provides a roadmap to address Michigan's school funding challenges.
  - Funding for Infrastructure Improvements
    - State Level
      - Foundation \$9,608 per pupil for 2023-24 school year

- Less than 1% goes to infrastructure funding
- Local Level
  - Bond Districts borrow funds up front and pay back over long period of time. Typically substantial amounts.
  - Sinking Fund Districts collect and annual allowance allowing them to pay for improvements as needed. Typically smaller amounts.
  - Challenges
    - District residents must vote/approve.
    - Tax rates must be raised or maintained.
    - Requests may not be enough to meet needs. District may need to lower requests to appease voters.
  - How other states are assessing this funding gap (see slide #9).
- Statewide School Infrastructure Study
  - SFRC is tasked with conducting study of all public K-12 buildings across the state by the end of 2024.
    - 3,000 school buildings and 270 million square feet
  - Goal is determining if it is more cost effective to bring each building up to standard or replace entire existing buildings.
  - The study is intended for the limited purpose of financial analysis and planning at a high-level, non-invasive assessment of building conditions focused on health, safety, and wellness.
  - The study is not a facility condition assessment for use in PQ Apps, or meant to identify or correct any issues or deficiencies regarding space, health, or code compliance, nor is it mandatory.
  - Districts will be provided a comprehensive report on their buildings at the end of the study.
  - Study will be conducted simultaneously in all 10 MAISA regions involving multiple firms using a standardized template for consistency.
  - Timeline (see slide #13)
    - Facility Condition Assessments Q1-Q3 2024
    - Energy Efficiency Audit Q1 2024 Q1 2025
    - FCA Report Shared with State & Districts Q4 2024
    - Energy Audit Report Shared with State & Districts Q2 2025
  - Scope of Facility Condition Assessment (see slide #14)
    - Health, safety, and wellness features
  - Districts will review high level district summary and building snapshots prior to it going to the state.
  - Energy audit is currently in the planning phase.
  - Progress to Date
    - 95% of Districts/ISDs have completed the FCA participation acknowledgement.

- Only Districts that agree to participate are eligible for Section 11x funding.
- Original Survey Parameters (see slide #19)
  - Critical information needed, building characteristics, scheduling, study data collection, and procurement
- Next Steps
  - Important Action Items for School Districts (see slide #21)
    - The SFRF needs critical information on district facilities immediately
      - Instructional vs non-instructional
      - Architect/Engineer/Construction Manager on record
      - Total building square footage
      - Will school building be open past 2025
    - 58% of Districts/ISDs have completed the full initial building survey. Additional survey components include recent work on buildings, year built, etc.
       Need to complete by October 31st.
    - Energy audit participation acknowledgement forms are due Friday, October 6th.
  - Upcoming
    - Communicate with your selected firm to provide preliminary information and schedule site assessments.
    - Communicate with individual schools on their assessment times and ensure access to relevant areas.
    - Attend kickoff meetings with your firms
    - Be available for future clarification after initial walk throughs.

- Who does the correspondence go out to?
  - Answer: To superintendents by region/ISD.
- Can you add business leaders from ISDs to the email LISTSERV?
  - Answer: Yes, they can be added as secondary contacts.
- How will funding be sent out?
  - Answer: Unknown at this time. Legislators are talking about it.
- How are you handling districts with infrastructure work scheduled over the next couple of years?
  - Answer: Will look at current buildings. Case-by-case basis.
     May not look at existing buildings with work already scheduled.
- How are you keeping floor plans safe and protected?

 Answer: Using Smartsheet, which is very secure. Public will not have access to floor plans. The final report will not include any floor plans.

- Transportation funding for local school districts
  - Section 22I \$125 million for 2023-24
  - MDE has partnered with the Macomb Intermediate School District and a coalition of transportation experts to conduct the study on district transportation costs required in section 22l(2).
  - MDE expects the study to be completed early in 2024.
- Section 27h, k, l, m
  - Employee compensation (MEA memo)
  - Office of Educator Excellence (OEE) (No memos)
- Section 31aa
  - Section 31aa and Section 97 rolled into 31aa.
  - Safety, SRO, at least 50% towards mental health
  - \$220 per student in funding for 2023-24
- Pending legislation
  - Labor day start
  - Evaluations
- MSBO specific
  - Leadership change going well
  - It has been a really busy fall
  - Working on practical professional development to support membership
  - Working on website potential updates to structure
  - Creating a Payroll LISTSERV
