2024 ELECTION SUMMARY

Federal Government

The 2024 election resulted in a significant shift in the balance of power for the Presidency and the legislative branch. Donald Trump has been reelected as the US President. The US Senate will have a Republican majority of 53 to 47 Democrats. Four seats flipped from Democratic to Republican.

The leadership of the House of Representatives remains in a Republican majority. Currently, Republicans have 218 seats and Democrats hold 213, with 4 yet to be called. However, there may be some vacancies as some members of congress are being tapped to join the Trump Administration. This puts additional pressure on a narrow majority. In Michigan, the 13 congressional House seats experienced one flip from one party to another. Michigan's delegation is now a 7-6 split between the two parties, favoring Republicans.

Michigan Government

In Michigan, the balance of power will shift as the House of Representatives changes from a Democratic majority to a Republican majority. This is the only part of the existing "trifecta" that was on the ballot this election season and signals a divided government coming in the new legislative session. The margins in both chambers between majority and minority will continue to be close, though. In the Senate, the Democrats 20-18 majority changes because Senator Kristen McDonald Rivet won her congressional bid and will move to the US House of Representatives. This will leave a vacancy until a special election occurs and leave a 19-18 majority for the Democrats. In the House, the Republicans flipped four seats and will now have a 58-52 majority. Leadership for the two caucuses in the House have been decided and Republican Matt Hall will serve as Speaker of the House. The Democrats selected Ranjeev Puri to serve as minority leader.

Michigan Education Boards

Statewide positions on education boards remain in Democratic majorities, but Republican candidates prevailed in several of the statewide elections. The state Board of Education will remain a 6-2 Democratic majority as the two current Republican incumbents Tom McMillan and Nikki Snyder were re-elected. The University of Michigan Board of Regents remains a 6-2 Democratic majority. Republican Carl Meyers won the open seat to replace fellow Republican Ron Weiser and Democrat Denise Ilitch won reelection.

On the Michigan State University Board of Trustees, the balance of power remains a 7-1 Democratic majority as GOP nominated candidate Mike Balow and incumbent Democrat Rebecca Bahar-Cook won. The Wayne State University Board of Governors also shifts from a 6-2 Democratic majority to a 5-3 majority as Republican incumbent Michael Busuito won reelection and Republican Sunny Reddy also won.

Michigan Supreme Court

Statewide election results for the Supreme Court resulted in a win for incumbent Justice Kyra Harris Bolden and a win for professor Kimberly Thomas who was seeking an open seat due to the retirement of Justice David Viviano. That means the composition of the court will shift to a 5-2 Democratic majority.

- SB651 Tobacco The bill amends the Youth Tobacco Act to add licensing requirements and prohibitions regarding sale and distribution of tobacco. The bill is receiving testimony in the Senate Regulatory Affairs Committee.
- **SB652 Tobacco –** The bill amends the Age of Majority Act to exempt the Michigan Regulation and Taxation of Marihuana Act and the Youth Tobacco Act. The bill is receiving testimony in the Senate Regulatory Affairs Committee.
- SB653 Tobacco the bill amends the Youth Tobacco Act to sunset several provisions, modify signage requirements, and rename the act. The bill is receiving testimony in the Senate Regulatory Affairs Committee.
- SB654 Tobacco The bill amends the Age of Majority Act to specify that it would not apply to the Michigan Regulation and Taxation of Marihuana Act (MRTMA). The bill is receiving testimony in the Senate Regulatory Affairs Committee.
- SB741 School Libraries The bill requires a school library in all public schools and participation in the interlibrary loan system. The bill is in the Senate Education Committee.
- **SB742 School Librarians –** The bill requires a certified school librarian in certain public schools. The bill is in the Senate Education Committee.



- **SB743 School Libraries –** The bill provides a designated individual to supervise pupils in a school library under certain conditions. The bill is in the Senate Education Committee.
- SB875 Immunizations The bill modifies the grade requirement for certain immunization records in the public health code and requires department to adopt the immunization schedule recommended by the federal centers for disease control and prevention. The bill is in the Senate Health Policy Committee.
- **SB876 Immunization –** The bill modifies certain provisions regarding immunization in the state school aid act. The bill is in the Senate Health Policy Committee.
- **SB877 Immunization –** The bill modifies grade requirement for certain immunization records in the revised school code. The bill is in the Senate Health Policy Committee.
- SB943 School Aid The bill modifies certain disclosure requirements for public schools. The bill passed out of the Senate Education Committee and awaits a vote of the full chamber.
- **SB944 Public School Academies –** The bill revises requirements for a management agreement with educational management organizations. The bill passed out of the Senate Education Committee and awaits a vote of the full chamber.
- SB945 Public School Academies The bill subjects educational management organizations to same bidding laws as public schools. The bill is in the Senate Education Committee.
- SB946 Public School Academies The bill provides additional requirements for oversight of public school academies by authorizing bodies. The bill passed out of the Senate Education Committee and awaits a vote of the full chamber.
- SB947 Public School Academies The bill restricts public school academy real estate transactions with certain entities. The bill passed out of the Senate Education Committee and awaits a vote of the full chamber.

- HB4089 School Safety The bill creates a nine-member School Safety and Mental Health Commission to consult with behavioral and mental health experts supporting atrisk youth. The bill received testimony in the House Education Committee.
- HB4092 School Safety The bill requires notification of tips reported under the OK2Say program. The bill received testimony in the House Education Committee.
- HB4095 School Safety The bill requires that public schools and nonpublic schools adopt and implement a standardized response terminology plan. The bill received testimony in the House Education Committee.

- HB4291 Youth Athletes The bill requires MDHHS to develop educational materials and training program regarding sudden cardiac arrest in athletes and their return to athletic activity. The bill received testimony in the House Health Policy Committee.
- HB4355 Collective Bargaining The bill updates a reference to 1947 PA 336, the state school aid act of 1979. The bill passed out of the House Labor Committee and awaits a vote of the full chamber.
- HB4482 Civil procedure The bill would revise the statute of limitations for minor victims of CSC to instead apply to any victim of CSC. The bill also extends the time period for filing after discovery from three years to seven years and the maximum age of the victim to 52. The bill passed out of the House Criminal Justice Committee and awaits a vote of the full chamber.
- HB4485 Criminal procedure The bill eliminates the statute of limitations for criminal indictments of CSC. The bill passed out of the House and is in the Senate Civil Rights, Judiciary and Public Safety Committee.
- HB4486 Torts The bill removes governmental immunity if an agency or employee knew or should have known about a prior act of CSC and failed to act or intervene to prevent subsequent CSC. The bill passed out of the House and is in the Senate Civil Rights, Judiciary and Public Safety Committee.
- HB4549 Substitute Teachers The bill modifies sunset for certain requirements concerning eligibility to serve as a substitute teacher. The bill passed out of the House Education Committee and awaits a vote of the full chamber.
- HB4648 School Aid The bill modifies pupil membership count day and the supplemental pupil count to provide for an alternative day for the counting of pupils who are absent due to a religious observance or holiday. The bill passed out of the House Education Committee and awaits a vote of full chamber.
- **HB4671 School Calendar –** The bill eliminates restrictions on school start date. The bill passed out of the House Education Committee and awaits a vote of full chamber.
- **HB4854 Students –** The bill permits indigenous individuals to wear traditional regalia and bring traditional objects in a school building. The bill received testimony in the House Higher Education Committee.
- **HB4928 School Vehicles –** The bill allows school bus stop-arm cameras and provides civil sanctions for violations. The bill passed out of the House and the Senate, and awaits signature into law by the governor.
- **HB4929 Civil Infractions –** The bill revises judicature act to reflect distribution of certain fines to school districts. The bill passed out of the House and the Senate, and awaits signature into law by the governor.
- HB4930 School Vehicles The bill allows school bus stop-arm cameras. The bill passed out of the House and the Senate, and awaits signature into law by the governor.
- HB4961 School Curriculum The bill establishes an environmental literacy task force
 to develop environmental literacy model curriculum and report on the curriculum. The bill
 received testimony in the House Education Committee.
- HB5025 Educational Instruction Access The bill repeals educational instruction access act. The bill received testimony in the House Education Committee.



- **HB5051 Education Curriculum –** The bill modifies merit curriculum requirement. The bill is in the House Education Committee.
- HB5063 Medical Marijuana The bill allows students to be treated with marihuanainfused products and CBD products during school. The bill is in the House Regulatory Reform Committee.
- **HB5064 Medical Marijuana –** The bill allows treating students with medical marihuana and CBD products at school. The bill is in the House Regulatory Reform Committee.
- **HB5098 Dyslexia –** The bill creates dyslexia resource guide advisory committee within the department of education. The bill is in the House Education Committee.

- **HB5309 School Zones –** The bill modifies the definition of school zone. The bill is in the House Transportation, Mobility and Infrastructure Committee.
- **HB5329 Seizures –** The bill establishes certain school requirements related to seizure awareness. The bill received testimony in the House Education Committee.
- **HB5334 Firearms –** The bill requires MDE to develop a model program of firearm safety instruction for students in grades 6 to 12 by June 1, 2025. The bill is in the House Judiciary Committee.
- HB5450 Firearms The bill requires DHHS to develop and provide information regarding the safe storage of firearms to the Department of Education. The bill passed out of the House and is in the Senate.
- HB5451 Firearms The bill requires districts to provide information regarding the safe storage of firearms to parents and legal guardians. The bill passed out of the House and is in the Senate.
- HB5456 School Code The bill provides inclusion of incidents involving possession or dissemination of sexually explicit or abusive material in required incident reporting. The bill is in the House Education Committee.
