Sean McLaughlin and John Andrejack from Michigan Department of Education did a presentation on allowable cost clarifications, correct use of function code 219 on the 4096; Equitable services and proportionate share; excess costs and MOE. The presentation is on the MSBO website.

Mr. Andrejack was honored by MSBO for his years of service to education.

Chris Frank brought it to the attention of the group that the "Michigan Blueprint for Special Education" has been developed and could be released soon. This is a legislative project that could change special education funding in Michigan. Under this proposal, funding would be based on the diagnoses of students rather than the number of students served. There is a question of where the funding would come from to support this initiative. This presentation is on the MSBO website.

Jason Helsen, MSBO gave a budget update; questions were being submitted to the state budget office for clarification;

David Ladd gave a legislative update; 32p was eliminated without a chance to let legislators know its importance in our communities; MPSERS hard to understand and causes confusion in the budget; Section 56 funding is not equal any more, it needs to change; expect a supplemental budget; revenue generation makes the future look uncertain; layoffs are being announced; unemployment rates are increasing; Perkins grant was moved to the Dept of Labor  
SE Preschool grant could be at risk of cuts
