

January 2024 CREC: School Aid Fund Net Revenue



January 2024 CREC: GF/GP Net Revenue



Pupil Membership Update

Total Pupil Membership

Due to the pandemic, total pupils declined by about 40,000 more than expected in FY 2021, although the drop was not fully experienced by districts until FY 2022. Total enrollment is expected to decline by about 7,500 pupils in FY 2024; 5,800 pupils in FY 2025; and 6,300 pupils in FY 2026.
