

Improvements to the Press Box at the competition Football Stadium

1999-01

SCOPE OF WORK: The scope of work for this project includes: the design work, documents and permits, and the complete rebuilding of the Press Box for our competition Football Stadium onto an existing foundation.

The press box was damaged by fire on 6/28/99, to the extent that the wooden 2nd floor of the building will have to be completely demolished and replaced. Our insurance company has determined the replacement value of the existing structure is \$16,462.

Chelsea School District is requesting approval for the portion of this project that is an improvement to our Press Box, including the design work associated with the improvement and reconstruction. Our Press box was a 2 story structure that was concrete block on the first floor and a wood frame construction for the 2nd floor. The new design utilizes the existing concrete block first floor, replaces the wooden structure for the 2nd floor, and adds a 3rd floor to the building.

The low bid to complete this work is \$24,750. The Chelsea School District considers the difference between the two amounts (the bid amount of \$24,750 less the insurance reimbursement of \$16,462 equals \$8,288) to be the amount of improvement that we are making to the press box facility.

We are requesting approval to pay for the improvement portion of this project with sinking fund revenue. The enhancements will improve the safety for the people using the press box, by eliminating the use of the roof for observation and filming. These activities will take place on the 3rd floor instead of the roof.

COST: Net cost for this project after the insurance payment is applied will be \$8,288 plus the design costs and inspections of \$2,000

The following are expenditures that we discussed on the phone:

- 1) United Enviro-Tech, Inc. Asbestos removal and disposal at Beach Middle School for \$ 81,239.00. There will also be additional smaller expenses relating to asbestos removal.
- Decorative Flooring Services, Inc. Removal of old flooring and installation of new floor coverings for Community Education classrooms which may possibly be used in the future for K-12 classrooms in the amount of \$ 28,636.35.

We would also like to obtain your approval for a few additional items to be paid out of the Sinking Fund:





1. Lab stations — These are acceptable sinking fund expenditures except for the purchase of movable parts. The movable parts are considered to be equipment or furniture and are not allowable from sinking fund money.

Playground equipment — Equipment can not be purchased from sinking fund money. Playground structures are an acceptable use of sinking fund money. A playground structure includes structures that require design work; site preparation; an estimated life of at lease 20 years; are built in compliance with federal guidelines; are constructed (not portable or snap together); and are intended to be a permanent structure. This will not include equipment that is used as a part of the structure, such as swings, slides ropes, nets and rubber or other items that are detachable and/or must be replaced on a regular basis. Single pieces of equipment, even if permanently attached to the ground, such as swing sets, slides, merry-go-rounds and teeter totters, are not considered to be a structure, but are equipment.

Projects:

- 1. Re-roofing project at the middle school. This re-roofing project will begin phase 1 to re-roof the middle school.

- 4. Remove the single pane windows on the south side of the middle school and replace with a thermo pane window. Remove the remaining single pane windows at the elementary, and replace with thermo panes. This will complete the window replacement project at the elementary that was started in 1998.
- 5. Construct a new bus parking lot and maintenance building. Currently the buses are parked in the elementary's parking lot and there is now place to work on buses if the weather is bad.
- 6. Pulverize existing asphalt and resurface the high school driveway. The new surface would consist of a 2" course layer and a 2" finish coat or possibly heavier due to traffic use.
- 7. Remove and replace the existing storm drain in the middle school parking lot with a larger one. Currently, there is only a 6" drain and during any significant rain fall it does not drain properly.
- 8. Remodel the football field. Tear up the existing turf, put crown on field, install an irrigation system, re-seed, and install new bleachers on the visitors side of the field.
- 9. Construct a new concession stand, restroom facility, and team rooms.
- 10. Construct a restroom and concession stand at the softball and track complex.

- 11. Install irrigation systems on the softball and baseball outfields.
- 12. Remodel elementary playground. Remove old equipment, grade area for better drainage, and install new aged appropriate playground equipment.
