- 4. <u>Erik Drake/Nancy Corner REMC Update</u>: Using same theme as 2 years ago...Billion Dollar Savings! Doing give aways; cameras, video conference, power towers, wobble chairs, Nancy Corner retiring Mike Richardson taking over in April-June transition. Just under 100,000 units forecast for purchasing, last year was about 130,000 units sold. Paper is still constrained. Doesn't look like it will get any better in the next 6 mths.
- 5. <u>Kate Cermack, MDE Update on Testing</u>: Taking over for Pietro WIDA happening now through March 25<sup>th</sup> all grades in the same 6-week window to allow flexibility with ELA exception having a shorter 4-week window. Mi-Access is still 7 weeks. There was a PowerPoint to refer to for all the details. Communication was resolved but unsatisfactory WIDA determines who get s comms. They were not sending to tech people. But instead, sent to coordinators. Raised issue and hoping they will change process. Make sure to log in to your MEIS account every three months otherwise your DRC account is blocked.
