- 3. Semifero Assessment

Testing windows are longer to give folks time to finish up. They are ending the Friday after Memorial Day. High school testing wraps up 5/21/2021. Benchmark assessments are legally required this year and several years into the future.

- 4. Erik Drake REMCSave.org
 - Device purchasing, we have sold 120,000 devices which is up from last year.
 - Supply chain and delivery timeframe. All the back orders from last year have been shipped. There could be a couple of districts left but glad to get that cleared out.

- Met with Intel and they are doing better with processors. We still have issues with touch screens, packaging, shipping, and customs. It is going to take a while.
- HP is saying 6 months for delivery. We are working with them to shorten that.
- Dell and Presidio is at 30 days and this has been good but as demand increases there could be a change.
- CDW has stock of Lenovo devices which may be another source.
- We are keeping on top of the resellers to help make devices available but not to create any new products.
- Copy bid expires May 31. They are having supply issues. Paper is under allocation, so the timelines are longer for delivery. The cost is going up. The new contract starts June 1 and the cost of paper is going up 12%. Contact local REMC directors for more information.
- All other contracts expire June 30 and new contracts start July 1. You may want to review before June 30.
- Tierney and Trox are merging. They will operate with separate salespeople and will maintain the course of business through December 31, 2021.
- 5. Polasek E-rate polasekj3@michigan.gov
 - FY 2021 Update
 - 58% of FRNs have received FCDLs awarding \$20,961,681.24 in discount (so far)
 - EBB Basics- It's Lifeline on Steroids!
 - It's not for you, but you should be telling all your families (especially your NSLP eligible folks)
 - Off-sets the cost of broadband service to a home
 - More info at <u>https://getemergencybroadband.org/</u>
 - Families must enroll in the program WITH THEIR PROVIDER
 - Up to a \$50/month discount on your broadband service and associated equipment rentals
 - Up to a \$75/month discount if your household is on qualifying Tribal lands
 - A one-time discount of up to \$100 for a laptop, tablet, or desktop computer (with a co-payment of more than \$10 but less than \$50)
 - Enrollment is OPEN for interested parties

 - Who is eligible to apply?
 - ✤ If you're eligible for E-Rate, you're eligible for the ECF
 - What locations are eligible for service?

- Off-campus locations where homework is done or remote learning is happening
- What services are eligible?
 - Fixed (DSL, cable or vendor-owned fiber service) and Wireless (hotspots)
 - Self-provisioned networks and Datacasting <u>ineligible</u> <u>UNLESS</u>..."no commercially available services exist"
- What devices are eligible?
 - Laptops, tablets, and hotspots
 - Maximum reimbursements on device types:
 - Hotspot device- \$250
 - Laptop/tablet- \$400 (waiver available for users with disabilities)
 - Desktop computers, cybersecurity solutions, and mobile phones are NOT eligible
- What is our window for eligible purchases?
 - July 1st, 2021 through June 30, 2022
 - When will the application go live?
 - The date has not been named
- How will applicants apply?
 - The FCC has stated that USAC will use the existing Form 471, BEAR (Form 472), and SPI Billing templates (Form 473)
 - There is no required bid period, but applicants must follow state and local procurement laws
- Where does CIPA fit in?
- CIPA will to apply laptops and computers purchased with ECF dollars and/or any device using ECF-purchased internet service
- What does my audit burden look like?
 - Same as E-Rate. All related documentation must be kept for a minimum of 10 years (or Forever/until the End of Time)
- Anything else?
 - Don't double dip with your federal funds!
