5. Testing – Katherine Cermack and Tim Tahaney, MDE

The College Board is transitioning to Digital Testing for Spring 2024 (April 8-26, 2024) with very limited exceptions. Technology Directors must be set up in EEM at building and district levels. Technology-related webinar will be offered in August/September. Workshops/webinars related to Technology requirements specific to Spring 24 testing will be offered in January.

Beginning next school year, the Windows and MacOS DRC client will need to be updated by using Group Policy or an MDM. Chromebooks and iPads will remain unaffected. No longer will end users be able to use the "auto update" option unless they happen to have local admin rights.
