Device purchasing closed July 30, 2022. We ended the year with 84,329 devices sold over \$25 million in sales over the previous year.

Only about ½ about what we sold in the previous year. We have sold almost one device per student.

Copy paper is still short but the company is now catching up. We still have color paper shortage and card stock is allocated.

Current paper quote goes until November 30 but we have the RFP out right now and will know the first or second week of November to see if they should order on the current contract or the new contract.

Everything furniture and supplies - expect to see a huge turnover in items starting January 2023. Most costs will be going up. Contracts are being looked at and out on the Website.

Five-year computer contract in 2019 thru 2024. This contract allows us to refresh the products on it and the re-bid and they are now open starting October 1, 2022 for the companies – see Erik for the list. Prices are higher but if you can fall into the device purchasing window your costs will fall under the REMC \$ave.

Training from REMC. SCECH eligible and can be used to maintain your certification.

## **Cyber Security**

Webb put out the question about cyber security. Nelson weighed in and as a consortium they are working with Microsoft to give notifications. They are trying to weed through the different products on this.

Couto just received a quote for Trend Micro for over \$41,000 per year for end user security.

Partridge mentioned that the group on Cyber Security - <u>espfork12.pdf (msbo.org)</u> as well as share this with the administrators to make this a priority.

Sharpsteen mentioned that insurances may stop ensuring districts which will then call attention to cyber security to end users.

Webb mentioned that he has signed on to CoSN to help push the funding through the federal government in hope the money will become available.

Sharpsteen has mentioned that SET SEG has a free system dashboard and scanning tool that is less than perfect, but it is a starting point with your tetra data.

Case has mentioned that state and ISD's are coming together to talk about cyber security. It is not about what it is but when it happens. Who has a plan? Have a bigger message for the district.

Sharpsteen signed up for MC3 messages and receives items on cyber security and he filters them down to the appropriate person.

Webb talked about cyber security incidents that we could share with this group

# Multi Factor Authentication (MFA or 2FA)

Nelson was asking to see who was setting up MFA.

Webb cannot do for student information or the finance software – not compatible.

Sharpsteen mentioned that he is rolling out it slowly leaving the superintendent for the last as not to stop it.

One district mentioned they got the union to back it so there was no push back.

Konja mentioned that he was told to get it started. Not much push back.

Hustek mentioned that he set it up for the teachers to be sent to their classroom phone and then realized that they couldn't get access at home. Now they use their cell phone.

Salzer mentioned that they were able to use backup apps and other phones as their choice and they set up over 2,000 staff on 2FA.
