THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 4. (1) "Elementary pupil" means a pupil in membership in
 grades K to 8 in a district not maintaining classes above the
 eighth grade 8 or in grades K to 6 in a district maintaining
 classes above the eighth grade 8 or a child enrolled and in regular
 attendance in a publicly funded prekindergarten setting.

6 (2) "Extended school year" means an educational program
7 conducted by a district in which pupils must be enrolled but not
8 necessarily in attendance on the pupil membership count day in an

extended year program. The mandatory clock hours must be completed
 by each pupil not more than 365 calendar days after the pupil's
 first day of classes for the school year prescribed. The department
 shall prescribe pupil, personnel, and other reporting requirements
 for the educational program.

6 (3) "Fiscal year" means the state fiscal year that commences7 October 1 and continues through September 30.

8 (4) "High school equivalency certificate" means a certificate9 granted for the successful completion of a high school equivalency10 test.

11 (5) "High school equivalency test" means the G.E.D. test 12 developed by the GED Testing Service, the Test Assessing Secondary 13 Completion (TASC) developed by CTS/McGraw-Hill, the HISET test 14 developed by Educational Testing Service (ETS), or another 15 comparable test approved by the department of labor and economic 16 opportunity.

17 (6) "High school equivalency test preparation program" means a 18 program that has high school level courses in English language 19 arts, social studies, science, and mathematics and that prepares an 20 individual to successfully complete a high school equivalency test. 21 (7) "High school pupil" means a pupil in membership in grades 22 7 to 12, except in a district not maintaining grades above the

23 eighth-grade 8.

Sec. 6. (1) "Center program" means a program operated by a district or by an intermediate district for special education pupils from several districts in programs for pupils with autism spectrum disorder, pupils with severe cognitive impairment, pupils with moderate cognitive impairment, pupils with severe multiple impairments, pupils with hearing impairment, pupils with visual

impairment, and pupils with physical impairment or other health 1 impairment. Programs for pupils with emotional impairment housed in 2 buildings that do not serve regular education pupils also gualify. 3 Unless otherwise approved by the department, a center program 4 either serves all constituent districts within an intermediate 5 6 district or serves several districts with less than 50% of the 7 pupils residing in the operating district. In addition, special 8 education center program pupils placed part-time in noncenter 9 programs to comply with the least restrictive environment 10 provisions of section 1412 of the individuals with disabilities 11 education act, 20 USC 1412, may be considered center program pupils for pupil accounting purposes for the time scheduled in either a 12 13 center program or a noncenter program.

14 (2) "District and high school graduation rate" means the15 annual completion and pupil dropout rate that is calculated by the16 center pursuant to nationally recognized standards.

17 (3) "District and high school graduation report" means a
18 report of the number of pupils, excluding adult education
19 participants, in the district for the immediately preceding school
20 year, adjusted for those pupils who have transferred into or out of
21 the district or high school, who leave high school with a diploma
22 or other credential of equal status.

(4) "Membership", except as otherwise provided in this subsection or this article, means for a district, a public school academy, or an intermediate district the sum of the product of .90 times the number of full-time equated pupils in grades K to 12 actually enrolled and in regular daily attendance in the district, public school academy, or intermediate district on the pupil membership count day for the current school year, plus the product

of .10 times the final audited count from the supplemental count 1 day of full-time equated pupils in grades K to 12 actually enrolled 2 and in regular daily attendance in the district, public school 3 academy, or intermediate district for the immediately preceding 4 school year. A district's, public school academy's, or intermediate 5 6 district's membership is adjusted as provided under section 25e for 7 pupils who enroll after the pupil membership count day in a strict 8 discipline academy operating under sections 1311b to 1311m of the 9 revised school code, MCL 380.1311b to 380.1311m. For 2020-2021 10 2021-2022 only, membership means for a district, a public school 11 academy, or an intermediate district, the sum of the product of .75 .90 times the district's, public school academy's, or intermediate 12 district's 2019-2020 membership as calculated under this section in 13 14 2019-2020 number of full-time equated pupils in grades K to 12 15 actually enrolled and in regular daily attendance in the district, public school academy, or intermediate district on the pupil 16 17 membership count day for the current school year and the product of 18 .25.10 times [the sum of (the product of .90 times the number of 19 full-time equated pupils engaged in pandemic learning for fall 2020 20 or, for a public school academy that operates as a cyber school, as that term is defined in section 551 of the revised school code, MCL 21 22 380.551, the number of full-time equated pupils in grades K to 12 actually enrolled and in regular daily attendance in the public 23 24 school academy on pupil membership count day for the current school 25 year) and (the product of .10 times the final audited count from the supplemental count day of full-time equated pupils in grades K 26 27 to 12 actually enrolled and in regular daily attendance in the district, public school academy, or intermediate district for the 28 29 immediately preceding school year)]. the final audited count of the

number of full-time equated pupils engaged in pandemic learning for 1 spring 2021, or, for a public school academy that operates as a 2 cyber school, as that term is defined in section 551 of the revised 3 school code, MCL 380.551, the final audited count from the 4 supplemental count day of full-time equated pupils in grades K to 5 6 12 actually enrolled and in regular daily attendance in the public 7 school academy for the immediately preceding school year. All pupil 8 counts used in this subsection are as determined by the department 9 and calculated by adding the number of pupils registered for 10 attendance plus pupils received by transfer and minus pupils lost 11 as defined by rules promulgated by the superintendent, and as corrected by a subsequent department audit. The amount of the 12 13 foundation allowance for a pupil in membership is determined under 14 section 20. In making the calculation of membership, all of the 15 following, as applicable, apply to determining the membership of a 16 district, a public school academy, or an intermediate district:

(a) Except as otherwise provided in this subsection, and pursuant to subsection (6), a pupil is counted in membership in the pupil's educating district or districts. An individual pupil must not be counted for more than a total of 1.0 full-time equated membership.

22 (b) If a pupil is educated in a district other than the 23 pupil's district of residence, if the pupil is not being educated as part of a cooperative education program, if the pupil's district 24 25 of residence does not give the educating district its approval to count the pupil in membership in the educating district, and if the 26 pupil is not covered by an exception specified in subsection (6) to 27 the requirement that the educating district must have the approval 28 29 of the pupil's district of residence to count the pupil in

1 membership, the pupil is not counted in membership in any district.

2 (c) A special education pupil educated by the intermediate3 district is counted in membership in the intermediate district.

4 (d) A pupil placed by a court or state agency in an on-grounds
5 program of a juvenile detention facility, a child caring
6 institution, or a mental health institution, or a pupil funded
7 under section 53a, is counted in membership in the district or
8 intermediate district approved by the department to operate the
9 program.

10 (e) A pupil enrolled in the Michigan Schools for the Deaf and
11 Blind is counted in membership in the pupil's intermediate district
12 of residence.

(f) A pupil enrolled in a career and technical education program supported by a millage levied over an area larger than a single district or in an area vocational-technical education program established under section 690 of the revised school code, MCL 380.690, is counted in membership only in the pupil's district of residence.

(g) A pupil enrolled in a public school academy is counted inmembership in the public school academy.

21 (h) For the purposes of this section and section 6a, for a cyber school, as that term is defined in section 551 of the revised 22 23 school code, MCL 380.551, that is in compliance with section 553a 24 of the revised school code, MCL 380.553a, a pupil's participation 25 in the cyber school's educational program is considered regular daily attendance, and for a district or public school academy, a 26 27 pupil's participation in a virtual course as that term is defined in section 21f is considered regular daily attendance. For the 28 29 purposes of this subdivision, for a pupil enrolled in a cyber

school and utilizing sequential learning, participation means that
 term as defined in the pupil accounting manual, section 5-o-d: 5-O D: requirements for counting pupils in membership-subsection 10.

4 (i) For a new district or public school academy beginning its
5 operation after December 31, 1994, membership for the first 2 full
6 or partial fiscal years of operation is determined as follows:

7 (i) Except as otherwise provided in this subparagraph, if If operations begin before the pupil membership count day for the 8 9 fiscal year, membership is the average number of full-time equated 10 pupils in grades K to 12 actually enrolled and in regular daily attendance on the pupil membership count day for the current school 11 12 year and on the supplemental count day for the current school year, as determined by the department and calculated by adding the number 13 14 of pupils registered for attendance on the pupil membership count 15 day plus pupils received by transfer and minus pupils lost as defined by rules promulgated by the superintendent, and as 16 17 corrected by a subsequent department audit, plus the final audited count from the supplemental count day for the current school year, 18 19 and dividing that sum by 2. However, for 2020-2021 only, if 20 operations begin before the pupil membership count day for the 21 fiscal year, except for a public school academy that operates as a 22 cyber school, as that term is defined in section 551 of the revised school code, MCL 380.551, membership is the average number of full-23 time equated pupils engaged in pandemic learning for fall 2020 and 24 25 full-time equated pupils engaged in pandemic learning for spring 26 2021, as that term is defined in section 6a, as determined by the 27 department and calculated by adding the number of pupils registered 28 for attendance on the pupil membership count day plus pupils received by transfer and minus pupils lost as defined by rules 29

promulgated by the superintendent, and as corrected by a subsequent department audit, plus the final audited count from the supplemental count day for the current school year, and dividing

4 that sum by 2.

5 (ii) If operations begin after the pupil membership count day for the fiscal year and not later than the supplemental count day 6 7 for the fiscal year, membership is the final audited count of the number of full-time equated pupils in grades K to 12 actually 8 9 enrolled and in regular daily attendance on the supplemental count 10 day for the current school year. , but, for 2020-2021 only, except for a public school academy that operates as a cyber school, as 11 12 that term is defined in section 551 of the revised school code, MCL 13 380.551, membership is the final audited count of the number of 14 full-time equated pupils engaged in pandemic learning for spring 15 2021, as that term is defined in section 6a.

16 (j) If a district is the authorizing body for a public school 17 academy, then, in the first school year in which pupils are counted 18 in membership on the pupil membership count day in the public 19 school academy, the determination of the district's membership 20 excludes from the district's pupil count for the immediately 21 preceding supplemental count day any pupils who are counted in the 22 public school academy on that first pupil membership count day who 23 were also counted in the district on the immediately preceding supplemental count day. 24

(k) For an extended school year program approved by the superintendent, a pupil enrolled, but not scheduled to be in regular daily attendance, on a pupil membership count day, is counted in membership.

29

(l) To be counted in membership, a pupil must meet the minimum

1 age requirement to be eligible to attend school under section 1147 2 of the revised school code, MCL 380.1147, or must be enrolled under 3 subsection (3) of that section, and must be less than 20 years of 4 age on September 1 of the school year except as follows:

5 (i) A special education pupil who is enrolled and receiving
6 instruction in a special education program or service approved by
7 the department, who does not have a high school diploma, and who is
8 less than 26 years of age as of September 1 of the current school
9 year is counted in membership.

10 (ii) A pupil who is determined by the department to meet all of 11 the following may be counted in membership:

12 (A) Is enrolled in a public school academy or an alternative
13 education high school diploma program, that is primarily focused on
14 educating pupils with extreme barriers to education, such as being
15 homeless as that term is defined under 42 USC 11302.

16 (B) Had dropped out of school.

17 (C) Is less than 22 years of age as of September 1 of the18 current school year.

(iii) If a child does not meet the minimum age requirement to be eligible to attend school for that school year under section 1147 of the revised school code, MCL 380.1147, but will be 5 years of age not later than December 1 of that school year, the district may count the child in membership for that school year if the parent or legal guardian has notified the district in writing that he or she intends to enroll the child in kindergarten for that school year.

(m) An individual who has achieved a high school diploma is not counted in membership. An individual who has achieved a high school equivalency certificate is not counted in membership unless the individual is a student with a disability as that term is

defined in R 340.1702 of the Michigan Administrative Code. An
individual participating in a job training program funded under
former section 107a or a jobs program funded under former section
107b, administered by the department of labor and economic
opportunity, or participating in any successor of either of those 2
programs, is not counted in membership.

7 (n) If a pupil counted in membership in a public school 8 academy is also educated by a district or intermediate district as 9 part of a cooperative education program, the pupil is counted in 10 membership only in the public school academy unless a written 11 agreement signed by all parties designates the party or parties in which the pupil is counted in membership, and the instructional 12 time scheduled for the pupil in the district or intermediate 13 14 district is included in the full-time equated membership 15 determination under subdivision (q) and section 101. However, for pupils receiving instruction in both a public school academy and in 16 17 a district or intermediate district but not as a part of a 18 cooperative education program, the following apply:

19 (i) If the public school academy provides instruction for at least 1/2 of the class hours required under section 101, the public 20 21 school academy receives as its prorated share of the full-time 22 equated membership for each of those pupils an amount equal to 1 23 times the product of the hours of instruction the public school academy provides divided by the number of hours required under 24 25 section 101 for full-time equivalency, and the remainder of the 26 full-time membership for each of those pupils is allocated to the 27 district or intermediate district providing the remainder of the hours of instruction. 28

29

(ii) If the public school academy provides instruction for less

than 1/2 of the class hours required under section 101, the 1 district or intermediate district providing the remainder of the 2 hours of instruction receives as its prorated share of the full-3 time equated membership for each of those pupils an amount equal to 4 5 1 times the product of the hours of instruction the district or 6 intermediate district provides divided by the number of hours 7 required under section 101 for full-time equivalency, and the 8 remainder of the full-time membership for each of those pupils is 9 allocated to the public school academy.

10 (o) An individual less than 16 years of age as of September 1 11 of the current school year who is being educated in an alternative 12 education program is not counted in membership if there are also 13 adult education participants being educated in the same program or 14 classroom.

15 (p) The department shall give a uniform interpretation of 16 full-time and part-time memberships.

17 (q) The number of class hours used to calculate full-time 18 equated memberships must be consistent with section 101. In determining full-time equated memberships for pupils who are 19 20 enrolled in a postsecondary institution or for pupils engaged in an internship or work experience under section 1279h of the revised 21 school code, MCL 380.1279h, a pupil is not considered to be less 22 23 than a full-time equated pupil solely because of the effect of his or her postsecondary enrollment or engagement in the internship or 24 25 work experience, including necessary travel time, on the number of class hours provided by the district to the pupil. 26

27 (r) Full-time equated memberships for pupils in kindergarten
28 are determined by dividing the number of instructional hours
29 scheduled and provided per year per kindergarten pupil by the same

number used for determining full-time equated memberships for 1 pupils in grades 1 to 12. However, to the extent allowable under 2 federal law, for a district or public school academy that provides 3 evidence satisfactory to the department that it used federal title 4 I money in the 2 immediately preceding school fiscal years to fund 5 6 full-time kindergarten, full-time equated memberships for pupils in 7 kindergarten are determined by dividing the number of class hours 8 scheduled and provided per year per kindergarten pupil by a number 9 equal to 1/2 the number used for determining full-time equated 10 memberships for pupils in grades 1 to 12. The change in the 11 counting of full-time equated memberships for pupils in 12 kindergarten that took effect for 2012-2013 is not a mandate.

(s) For a district or a public school academy that has pupils 13 14 enrolled in a grade level that was not offered by the district or 15 public school academy in the immediately preceding school year, the 16 number of pupils enrolled in that grade level to be counted in 17 membership is the average of the number of those pupils enrolled 18 and in regular daily attendance on the pupil membership count day and the supplemental count day of the current school year. $\frac{1}{7}$ but, 19 20 for 2020-2021 only, except for a public school academy that operates as a cyber school, as that term is defined in section 551 21 of the revised school code, MCL 380.551, the number of pupils 22 23 enrolled in that grade level to be counted in membership is the 24 average of the number of those pupils engaged in pandemic learning 25 for fall 2020 and the number of those pupils engaged in pandemic learning for spring 2021, as that term is defined in section 6a, as 26 27 determined by the department. Membership is calculated by adding the number of pupils registered for attendance in that grade level 28 29 on the pupil membership count day plus pupils received by transfer

and minus pupils lost as defined by rules promulgated by the
 superintendent, and as corrected by subsequent department audit,
 plus the final audited count from the supplemental count day for
 the current school year, and dividing that sum by 2.

5 (t) A pupil enrolled in a cooperative education program may be
6 counted in membership in the pupil's district of residence with the
7 written approval of all parties to the cooperative agreement.

8 (u) If, as a result of a disciplinary action, a district 9 determines through the district's alternative or disciplinary 10 education program that the best instructional placement for a pupil 11 is in the pupil's home or otherwise apart from the general school population, if that placement is authorized in writing by the 12 district superintendent and district alternative or disciplinary 13 14 education supervisor, and if the district provides appropriate 15 instruction as described in this subdivision to the pupil at the 16 pupil's home or otherwise apart from the general school population, the district may count the pupil in membership on a pro rata basis, 17 with the proration based on the number of hours of instruction the 18 district actually provides to the pupil divided by the number of 19 20 hours required under section 101 for full-time equivalency. For the purposes of this subdivision, a district is considered to be 21 22 providing appropriate instruction if all of the following are met:

(i) The district provides at least 2 nonconsecutive hours of
instruction per week to the pupil at the pupil's home or otherwise
apart from the general school population under the supervision of a
certificated teacher.

27 (*ii*) The district provides instructional materials, resources,
28 and supplies that are comparable to those otherwise provided in the
29 district's alternative education program.

(*iii*) Course content is comparable to that in the district's
 alternative education program.

3 (*iv*) Credit earned is awarded to the pupil and placed on the4 pupil's transcript.

5 (v) If a pupil was enrolled in a public school academy on the 6 pupil membership count day, if the public school academy's contract 7 with its authorizing body is revoked or the public school academy 8 otherwise ceases to operate, and if the pupil enrolls in a district 9 within 45 days after the pupil membership count day, the department 10 shall adjust the district's pupil count for the pupil membership 11 count day to include the pupil in the count.

12 (w) For a public school academy that has been in operation for 13 at least 2 years and that suspended operations for at least 1 14 semester and is resuming operations, membership is the sum of the 15 product of .90 times the number of full-time equated pupils in grades K to 12 actually enrolled and in regular daily attendance on 16 17 the first pupil membership count day or supplemental count day, whichever is first, occurring after operations resume, plus the 18 19 product of .10 times the final audited count from the most recent 20 pupil membership count day or supplemental count day that occurred 21 before suspending operations, as determined by the superintendent. 22 , but, for 2020-2021 only, except for a public school academy that 23 operates as a cyber school, as that term is defined in section 551 24 of the revised school code, MCL 380.551, membership is the sum of 25 the product of .90 times the number of full-time equated pupils 26 engaged in pandemic learning for fall 2020 or the number of full-27 time equated pupils engaged in pandemic learning for spring 2021, 28 as that term is defined in section 6a, whichever applies first 29 after operations resume, plus the product of .10 times the final

audited count from the most recent pupil membership count day or 1 2 supplemental count day that occurred before suspending operations, as determined by the superintendent. 3

(x) If a district's membership for a particular fiscal year, 4 5 as otherwise calculated under this subsection, would be less than 6 1,550 pupils, the district has 4.5 or fewer pupils per square mile, 7 as determined by the department, and the district does not receive 8 funding under section 22d(2), the district's membership is 9 considered to be the membership figure calculated under this 10 subdivision. If a district educates and counts in its membership 11 pupils in grades 9 to 12 who reside in a contiguous district that does not operate grades 9 to 12 and if 1 or both of the affected 12 districts request the department to use the determination allowed 13 14 under this sentence, the department shall include the square 15 mileage of both districts in determining the number of pupils per 16 square mile for each of the districts for the purposes of this 17 subdivision. If a district has established a community engagement 18 advisory committee in partnership with the department of treasury, 19 is required to submit a deficit elimination plan or an enhanced 20 deficit elimination plan under section 1220 of the revised school code, MCL 380.1220, and is located in a city with a population 21 between 9,000 and 11,000 that is in a county with a population 22 between 155,000 and 160,000, the district's membership is 23 24 considered to be the membership figure calculated under this 25 subdivision. The membership figure calculated under this 26 subdivision is the greater of the following: 27 (i) The average of the district's membership for the 3-fiscal-

year period ending with that fiscal year, calculated by adding the 28 district's actual membership for each of those 3 fiscal years, as 29

otherwise calculated under this subsection, and dividing the sum of
 those 3 membership figures by 3.

3 (ii) The district's actual membership for that fiscal year as4 otherwise calculated under this subsection.

5 (v) Full-time equated memberships for special education pupils 6 who are not enrolled in kindergarten but are enrolled in a 7 classroom program under R 340.1754 of the Michigan Administrative Code are determined by dividing the number of class hours scheduled 8 9 and provided per year by 450. Full-time equated memberships for 10 special education pupils who are not enrolled in kindergarten but are receiving early childhood special education services under R 11 12 340.1755 or R 340.1862 of the Michigan Administrative Code are 13 determined by dividing the number of hours of service scheduled and 14 provided per year per-pupil by 180.

(z) A pupil of a district that begins its school year after Labor Day who is enrolled in an intermediate district program that begins before Labor Day is not considered to be less than a fulltime pupil solely due to instructional time scheduled but not attended by the pupil before Labor Day.

20 (aa) For the first year in which a pupil is counted in 21 membership on the pupil membership count day in a middle college 22 program, the membership is the average of the full-time equated 23 membership on the pupil membership count day and on the 24 supplemental count day for the current school year, as determined 25 by the department. If a pupil described in this subdivision was 26 counted in membership by the operating district on the immediately 27 preceding supplemental count day, the pupil is excluded from the district's immediately preceding supplemental count for the 28 purposes of determining the district's membership. 29

25 (g) "HHS-SAMHSA" means the HHS Substance Abuse and Mental26 Health Services Project.

27 Sec. 41. (1) For a district to be eligible to receive funding
28 under this section, the district must administer to English
29 language learners the English language proficiency assessment known

1 as the "WIDA ACCESS for English language learners" or the "WIDA 2 Alternate ACCESS". From the appropriation—state school aid fund 3 money appropriated in section 11, there is allocated an amount not 4 to exceed \$13,000,000.00 for 2020-2021-2021-2022 for payments to 5 eligible districts for services for English language learners who 6 have been administered the WIDA ACCESS for English language 7 learners.

8 (2) The department shall distribute funding allocated under
9 subsection (1) to eligible districts based on the number of full10 time equivalent English language learners as follows:

26 (3) If funds allocated under subsection (1) are insufficient
27 to fully fund the payments as prescribed under subsection (2), the
28 department shall prorate payments on an equal percentage basis,
29 with the same percentage proration applied to all funding

1 categories.

under sections 611 to 619 1411 to 1419 of part B of the individuals 1 with disabilities education act, 20 USC 1411 to 1419, estimated at 2 \$370,000,000 for 2019-2020 and \$375,000,000.00 \$380,000,000.00 3 for 2020-2021, 2021-2022, plus any carryover federal funds from 4 previous year appropriations. The allocations under this subsection 5 6 are for the purpose of reimbursing districts and intermediate 7 districts for special education programs, services, and special 8 education personnel as prescribed in article 3 of the revised 9 school code, MCL 380.1701 to 380.1761; net tuition payments made by 10 intermediate districts to the Michigan Schools for the Deaf and 11 Blind; and special education programs and services for pupils who are eligible for special education programs and services according 12 to statute or rule. For meeting the costs of special education 13 programs and services not reimbursed under this article, a district 14 15 or intermediate district may use money in general funds or special education funds, not otherwise restricted, or contributions from 16 districts to intermediate districts, tuition payments, gifts and 17 18 contributions from individuals or other entities, or federal funds 19 that may be available for this purpose, as determined by the 20 intermediate district plan prepared under article 3 of the revised school code, MCL 380.1701 to 380.1761. 7 (16) For a public school academy that is a cyber school, as 8 that term is defined in section 551 of the revised school code, MCL 9 380.551, and is in compliance with section 553a of the revised 10 school code, MCL 380.553a, that enrolls a pupil under this section, 11 the intermediate district in which the cyber school is located shall ensure that the cyber school complies with sections 1701a, 12 13 1703, 1704, 1751, 1752, 1756, and 1757 of the revised school code, 14 MCL 380.1701a, 380.1703, 380.1704, 380.1751, 380.1752, 380.1756, 15 and 380.1757; applicable rules; and the individuals with 16 disabilities education act, Public Law 108-446.

 department shall not make any adjustment to these payments after
 the final installment payment under section 17b is made.

Sec. 152b. (1) From the general fund money appropriated under section 11, there is allocated an amount not to exceed \$2,500,000.00 for 2017-2018 and an amount not to exceed \$250,000.00 \$2,500,000.00 for 2018-2019 2021-2022 to reimburse actual costs incurred by nonpublic schools in complying with a health, safety, or welfare requirement mandated by a law or administrative rule of this state.

14 (2) By January 1 of each applicable fiscal year, the 15 department shall publish a form for reporting actual costs incurred 16 by a nonpublic school in complying with a health, safety, or welfare requirement mandated under state law containing each 17 18 health, safety, or welfare requirement mandated by a law or 19 administrative rule of this state applicable to a nonpublic school 20 and with a reference to each relevant provision of law or 21 administrative rule for the requirement. The form shall be posted on the department's website in electronic form. 22

(3) By June 30 of each applicable fiscal year, a nonpublic
school seeking reimbursement for actual costs incurred in complying
with a health, safety, or welfare requirement under a law or
administrative rule of this state during each applicable school
year shall submit a completed form described in subsection (2) to
the department. This section does not require a nonpublic school to
submit a form described in subsection (2). A nonpublic school is

not eligible for reimbursement under this section if the nonpublic
 school does not submit the form described in subsection (2) in a
 timely manner.

4 (4) By August 15 of each applicable fiscal year, the 5 department shall distribute funds to each nonpublic school that 6 submits a completed form described under subsection (2) in a timely 7 manner. The superintendent shall determine the amount of funds to 8 be paid to each nonpublic school in an amount that does not exceed 9 the nonpublic school's actual costs in complying with a health, 10 safety, or welfare requirement under a law or administrative rule 11 of this state. The superintendent shall calculate a nonpublic 12 school's actual cost in accordance with this section.

13 (5) If the funds allocated under this section are insufficient 14 to fully fund payments as otherwise calculated under this section, 15 the department shall distribute funds under this section on a 16 prorated or other equitable basis as determined by the 17 superintendent.

18 (6) The department may review the records of a nonpublic
19 school submitting a form described in subsection (2) only for the
20 limited purpose of verifying the nonpublic school's compliance with
21 this section. If a nonpublic school does not allow the department
22 to review records under this subsection, the nonpublic school is
23 not eligible for reimbursement under this section.

(7) The funds appropriated under this section are for purposes
related to education, are considered to be incidental to the
operation of a nonpublic school, are noninstructional in character,
and are intended for the public purpose of ensuring the health,
safety, and welfare of the children in nonpublic schools and to
reimburse nonpublic schools for costs described in this section.

(8) Funds allocated under this section are not intended to aid
 or maintain any nonpublic school, support the attendance of any
 student at a nonpublic school, employ any person at a nonpublic
 school, support the attendance of any student at any location where
 instruction is offered to a nonpublic school student, or support
 the employment of any person at any location where instruction is
 offered to a nonpublic school student.

8 (9) For purposes of this section, "actual cost" means the 9 hourly wage for the employee or employees performing a task or 10 tasks required to comply with a health, safety, or welfare 11 requirement under a law or administrative rule of this state 12 identified by the department under subsection (2) and is to be 13 calculated in accordance with the form published by the department 14 under subsection (2), which shall include a detailed itemization of 15 costs. The nonpublic school shall not charge more than the hourly 16 wage of its lowest-paid employee capable of performing a specific 17 task regardless of whether that individual is available and 18 regardless of who actually performs a specific task. Labor costs 19 under this subsection shall be estimated and charged in increments 20 of 15 minutes or more, with all partial time increments rounded down. When calculating costs under subsection (4), fee components 21 shall be itemized in a manner that expresses both the hourly wage 22 23 and the number of hours charged. The nonpublic school may not 24 charge any applicable labor charge amount to cover or partially 25 cover the cost of health or fringe benefits. A nonpublic school 26 shall not charge any overtime wages in the calculation of labor 27 costs.

28 (10) For the purposes of this section, the actual cost29 incurred by a nonpublic school for taking daily student attendance

shall be considered an actual cost in complying with a health,
 safety, or welfare requirement under a law or administrative rule
 of this state. Training fees, inspection fees, and criminal
 background check fees are considered actual costs in complying with
 a health, safety, or welfare requirement under a law or
 administrative rule of this state.

7 (11) The funds allocated under this section for 2017-2018 are 8 a work project appropriation, and any unexpended funds for 2017-2018 are carried forward into 2018-2019. The purpose of the work 9 project is to continue to reimburse nonpublic schools for actual 10 11 costs incurred in complying with a health, safety, or welfare requirement mandated by a law or administrative rule of this state. 12 13 The estimated completion date of the work project is September 30, 14 2020.2022.

15 (12) The funds allocated under this section for 2018-2019 are a work project appropriation, and any unexpended funds for 2018-16 17 2019 are carried forward into 2019-2020. The purpose of the work 18 project is to continue to reimburse nonpublic schools for actual 19 costs incurred in complying with a health, safety, or welfare 20 requirement mandated by a law or administrative rule of this state. 21 The estimated completion date of the work project is September 30, 2020.**2022**. 22

(13) The funds allocated under this section for 2021-2022 are a work project appropriation, and any unexpended funds for 2021-2022 are carried forward into 2022-2023. The purpose of the work project is to continue to reimburse nonpublic schools for actual costs incurred in complying with a health, safety, or welfare requirement mandated by a law or administrative rule of this state. The estimated completion date of the work project is September 30,

1 2023.

(14) The department shall reimburse nonpublic schools for
actual costs incurred in complying with health, safety, or welfare
requirements under a law or administrative rule of this state from
2018-2019 through 2020-2021 using work project funds or, if those
funds are insufficient to fund reimbursements under this
subsection, from the allocation under subsection (1).
