- Start creating or enhance your existing “To Do Calendar” of events/actions that regularly occur
- Some events/actions may not be applicable to your school
- Get a basic explanation for each event/action
- Please ask us for more information if needed

April

- Plan for upcoming equipment financing
 - Installment purchase agreements
 - True leases
 - Look for “bad” terms
 - Do not trust vendor “provided” financing
 - Contact counsel early – please...
 - Ask “how are we paying for these?”
- Plan for May debt service payments, if applicable

May (1)

- Prepare, approve, and file L-4029 by June 30, if necessary for summer tax levy and consider impact with budget hearing
- Assess impact of any Headlee reductions
- Review any county delinquent tax settlements
- August election deadline - May 14, 2024

May (2)

- Plan for cash flow borrowing
 - Confirm qualified status?
 - Prepare cash flow
 - Contact counsel
 - June board meeting for MFA borrowing
 - MFA documents available around May 1
- Start process for ISD board member biennial elections
 - Only if board is not popularly elected (MCL 380.614)

June

- Complete application for MFA cash flow borrowing
- Budget Adoption
- Budget Hearing
 - Uniform Budgeting & Accounting Act
 - Section 16 to avoid truth-in-taxation (MCL 141.436)
 - Publish notice 6 days prior (MCL 141.412)
- Consolidated Application due June 30
- School Infrastructure Report (SID)

July

- Board of education member election petitions filed with school election official (MCL 168.303)
 - 15th Tuesday before election day
- At-Risk report due by July 15
- Continue work on cash flow borrowing
- School Loan Revolving Fund application deadline is August 1
 - applications need board approval

August

- Pay prior cash flow borrowing and close on current borrowing
 - File significant event filing, if applicable
- November election deadline – August 13, 2024
- Relax?
 - NO – Audit Time

September

- Prepare, approve, and file L-4029 by September 30
- File Special Education cost report
- File Transportation cost report
- Plan/adopt/file annual summer tax levy resolution
 - If establishing new summer tax levy: contact attorney
 - If adjusting collection %: contact attorney
 - Deadline is December 31

October

- Plan for November debt service payments, if applicable
- File CTEIS cost report
- Final Expenditure reports for Consolidated Grants
 - e.g., Title I, Title IIa, Title IV
- Discuss summer and winter tax collections with board

November

- Board member elections
 - Certificate of acceptance
- Audit and FID filing by November 1
- Qualified Status filing with Treasury after audit filing
 - December 31 deadline
- Plan for annual continuing disclosure filings in December
- Catamaran filing opens

December

- File for qualified status by December 31
- Adopt & file annual summer tax resolution by December 31
- Continuing disclosure filings by late December

January/February/March

- File W-2's and 1099's
- File Michigan Annual Withholding and Sales Tax report
- Amend budgets
- Start budget process for next year
- Review current millage expirations and plan elections
- May 2025 election deadline – February 11, 2025
- SAM.gov annual renewal (required for direct federal funds)
