Certification

MSBO offers practical, highly focused voluntary certification programs for all aspects of your business operations. MSBO offers 14 separate certification tracks: including four for business office personnel; three for pupil accounting; and managers of food service, operations, purchasing, facilities, transportation, human resources, and technology.

Michigan Association of School Administrators (MASA) and the Michigan Association of School Boards (MASB) endorse MSBO's voluntary certification.

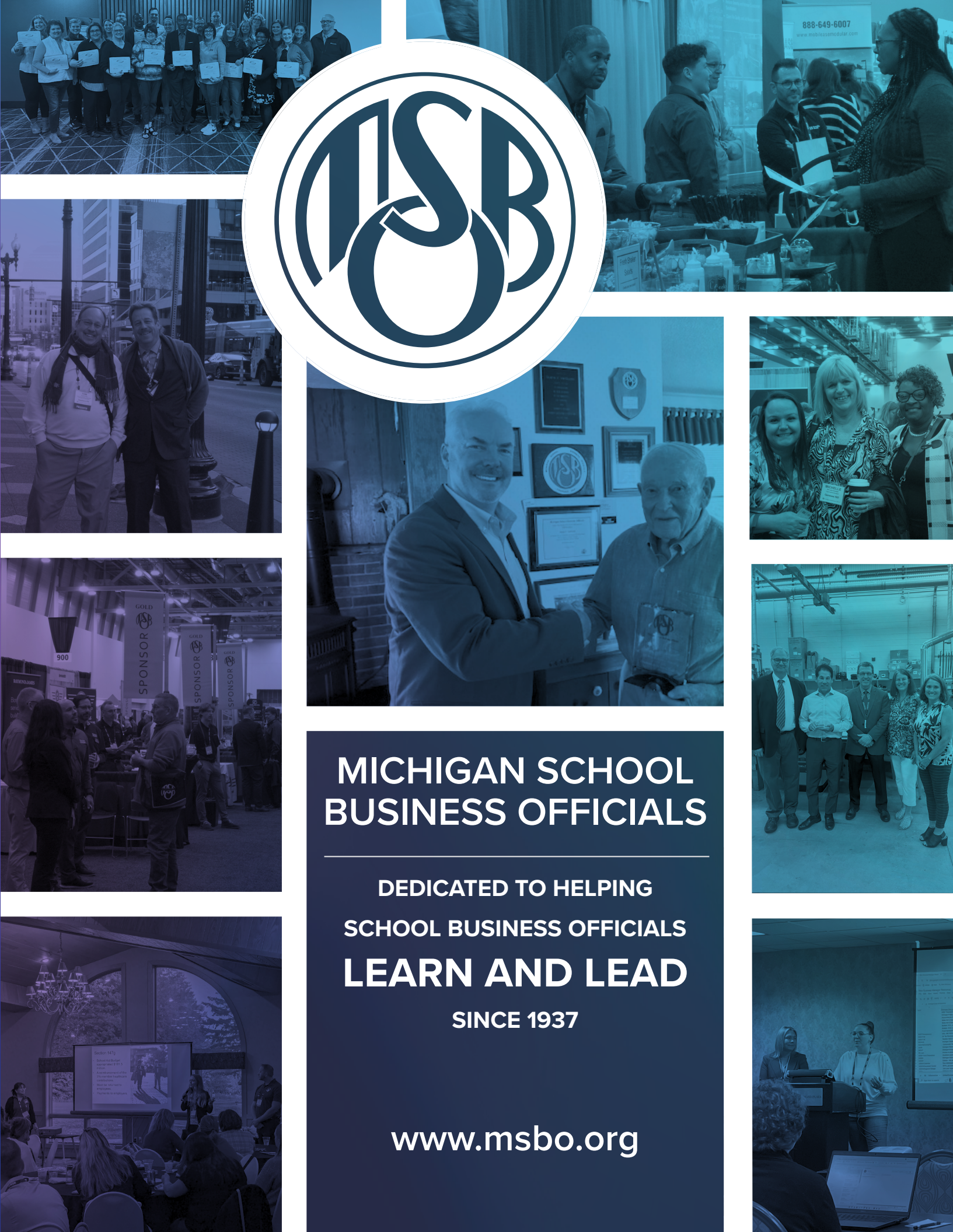
