Major Boilerplate Changes from FY 2024-25 Year-to-Date:

- 1. Improving Student Outcomes. The Governor included new language requiring districts with buildings identified as needing additional supports to direct additional foundation and at-risk funding for targeted interventions (Sec. 16), more equitably allocate existing at-risk dollars toward buildings needing extra support (Sec. 31a), require districts to notify parents regarding the status of the buildings their children attend (Sec. 16d), and intent language to include a distribution based on performance funding metrics beginning in FY 2026-27 (Sec. 16e).
- 2. Great Start Readiness Program. The Governor removed income eligibility thresholds from the program and removed various prescriptive requirements, giving more discretion to MiLEAP regarding the administration of the program (Sec. 32d). Also restructured payments around the concept of a "GSRP foundation allowance" and modified the distribution formula to be more aligned with requested enrollment (Sec. 39).
- 3. Tuition for Nonresident Pupils. The Governor eliminated the ability for districts to charge tuition for nonresident pupils (Sec. 111).
- **4. Nonpublic Schools.** The Governor removed nonpublic schools from the list of eligible recipients for mental health and school safety grants (Sec. 31aa) and robotics funding (Sec. 99h).
- **5. Repealed Sections.** The Governor repealed sections related to the reimbursement for nonpublic schools mandates (Sec. 152b) and various one-time funding programs.
