- PowerSchool Update
- PowerSchool is handling notifications through Experian
- Round 1 of ISD participation complete
- Round 2 is MiSecure contacting individual school districts to make sure all school districts are aware of the 97g MiSecure CrowdStrike MDR free server program. District ransomware incident in December 2024
 - District chose not to pay the ransom
 - Cybersecurity Insurance activated a incident response team to help the district.
 - District and Cybersecurity Response team verified uncompromised backups
 - Installed Crowdstrike across all servers and workstations in the district
 - The district was able to restore servers from backups and return to service
 - The district was able to operate without closure using Google Classrooms and hot spots.
 - Ransomware group is now trying to blackmail the district with the release of the data extracted from the district while the ransomware group was encrypting the district's servers
